Reclassification of Promoter Apollo Trading and Finance Private Limited, one of the Promoters of International Data Management Limited (the Company), vide its letter dated May 2, 2025, requested reclassification of its status from Promoter to Public under Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Board of Directors, at its meeting held on May 28, 2025, considered and approved the said request, subject to receipt of no-objection from BSE Limited, approval of the shareholders of the Company, and other requisite approvals, if any. Pursuant to the Boards approval, the Company submitted an application to BSE Limited on May 31, 2025 for obtaining its no-objection to the proposed reclassification. BSE Limited, vide its letter dated September 12, 2025, conveyed its no-objection to the said reclassification. Subsequently, the Company issued a Postal Ballot Notice dated October 7, 2025, seeking shareholders approval for the reclassification of Apollo Trading and Finance Private Limited from Promoter category to Public category. The result of postal ballot will be declared on or before 10 November, 2025.
