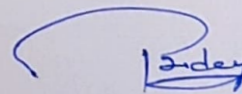

To the Board of Directors of International Data Management Limited

1. We have reviewed the accompanying Statement of unaudited financial results of **International Data Management Limited** ("the Company") for the quarter & half year ended 30th September 2025, ("The Statement").
